REVIEW OF THE FINANCIAL STATEMENTS

September 2020 unaudited financial statements were made available via Drop Box and discussed during the meeting. No questions about the financials were asked after a summary was given by the Secretary. A motion to accept the unaudited financial reports for September 2020 was made by Commissioner Bankston and seconded by Commissioner Seever. The motion to accept the unaudited financial reports for September 2020 were approved with a unanimous vote at 3:42 pm CST.

SECRETARY'S REPORT

Secretary's Report was presented to the board with a general operations sections report along with the Capital Fund Grant program report and discussed both during this time. A summary of each item on the Secretary's Report was sent out prior to the board meeting and then discussed. Statistics for LIPH and Section 8 programs for September 2020 were given out and summarized. A motion to approve the Secretary's Report into the Minutes was made by Commissioner Bankston and seconded by Commissioner Phillips. NEW BUSINESS

A. Resolution No. 1505 – Approval of House Rules for Hocker Heights, Pleasant Heights and Southview Manor

Administration explained to the Board that the housing authority used to utilize House Rules for all properties but over the years they were either misplaced, lost or discarded by accident. It is administration's desire to recreate and update these House Rules for all three properties



and have them implemented again. The House Rules are already referenced in the IHA dwelling lease. After final discussion, Commissioner Bankston made the motion for approval and Commissioner Phillips seconded. Votes were given as follows: Commissioner Rose – Aye; Commissioner Seever – Aye; Commissioner Bankston – Aye; Commissioner Leakey – Aye; Commissioner Phillips – Aye. Resolution No. 1505 was approved by unanimous vote at 4:01 pm CST.

B. Resolution No. 1506 – Approval of the Audited Submission of the Independent Audit by Smith, Marion and Company

Administration explained to the Board that HUD requires each housing authority to have an Independent Audit done for all programs that the housing authority oversees. Administration is bringing to the board the FYE 03/31/2020 Independent Audit results that will be submitted to HUD via the FASPHA system and the Federal Audit Clearinghouse websites. There were no Audit Findings found or issued against the Housing Authority by the Auditors. After final discussion, Commissioner Bankston made the motion for approval and Commissioner Leakey seconded. Votes were given as follows: Commissioner Rose – Aye; Commissioner Seever – Aye; Commissioner Bankston – Aye; Commissioner Leakey – Aye; Commissioner Phillips – Aye. Resolution No. 1506 was approved by a unanimous vote at 4:03 pm CST.

C. Vote to Enter Into Closed Session for Executive Director Contract Negotiations (pursuant to Section 610.021 (3) of Missouri Sunshine Law)
